APPLICATION REQUIREMENTS

The application requirements for candidates coming from abroad are as follows:

1. Provided that they are in the last year of high school or have graduated;

- a. Foreign nationals,
- b. Those who are Turkish Citizens by birth but have received permission from the Ministry of Internal Affairs to renounce Turkish Citizenship, and those who certify that their minor children registered in the Turkish Citizenship Renounce Document have a document regarding the exercise of the rights granted under the Turkish Citizenship Law, (Article 7 of the Turkish Citizenship Law No. 5901 contains the provision "(1) A child born in marriage to a Turkish citizen mother or father in Türkiye or abroad is a Turkish citizen" and it is beneficial for candidates who will apply for admission quotas from abroad to review the Turkish Citizenship Law).
- c. Those who became Turkish citizens with the citizenship acquired later while they were foreign nationals/dual nationals in this situation,
- d. 1) Among the Turkish national students who attended secondary education abroad before 01/02/2013, those who completed the last three years of their secondary education (high school) in a foreign country other than TRNC can apply for student

admission quotas from abroad" (including those who completed their entire secondary education (high school) in Turkish schools opened by the Ministry of Education in a foreign country other than TRNC),

2) Candidates who started secondary education abroad after 01/02/2013 and those who completed their entire secondary education (high school) in a foreign country other than TRNC (including those who completed their entire secondary education (high school) in Turkish schools opened by the Ministry of Education in a foreign country other than TRNC) can apply for international admission quotas,

- e. Applications are admitted from those who are TRNC citizens, reside in TRNC, have completed their secondary education in TRNC and have GCEAL exam results, and those who have or will have GCEAL exam results by registering and studying at colleges and high schools in other countries between 2005-2010.
- 2. Refusal to admit the applications of the candidates;
 - a) Those who are citizens of the Republic of Türkiye and have completed all of their secondary education in Türkiye or the TRNC,
 - b) TRNC nationals (except those who have completed all of their secondary education in TRNC high schools and have GCE AL results, and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),
 - c) Those who have dual citizenship and whose first nationality is Turkish at birth, as defined in paragraph (b) of Article 1, (except for those who meet the conditions in clause (1) of paragraph d of Article 1)
 - d) Dual nationals, one of whose nationalities is TRNC (except for those who have completed all of their secondary education in TRNC high schools and have GCE AL results, and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),
 - e) Those who are Turkish nationals and who studied at schools within the embassies in Türkiye and foreign high schools in Türkiye, or those who have dual citizenship whose first nationality is Turkish at birth as defined in paragraph (b) of Article 1.

ACCEPTANCE REQUIREMENTS AND REGISTRATION GUIDELINES

Students coming from abroad must meet the following conditions in order to be admitted to the University;

- a. Having taken one of the equivalent exams listed in the supplementary table (Table-1) in the status of internationally and nationally valid high school graduation and/or university entrance exams and having achieved the minimum score shown in the table.
- b. Having a secondary school graduation score in their system.
- c. Candidates can apply to a maximum of 5 programs. Students are placed in a program according to the score system determined by the University based on the order of preference. In placement, the scores of the candidates (Table-1) for the exams are converted into a hundred-score system to admit the highest 100 (one hundred) score. Then, the placement process is continued based on the graduation score. In case of equality in placement scores, preference is given to the younger one, then the one who has newly graduated from secondary education.
- d. The evaluation and placement procedures of the candidates who apply to the programs that admit students with a special aptitude exam are carried out in accordance with their own principles and procedures on the dates to be announced by the University.

- e. The amount of financial security to continue their higher education in our country is determined by the University Administrative Board in order to ensure that the students who will be admitted from abroad.
- f. According to the results of the evaluation, students who are entitled to enroll in the University must register with the necessary documents between the dates determined by the University Senate.
- g. Students' Turkish language proficiency level is determined according to the Turkish Language Proficiency Certificate of the Turkish Language Teaching Research and Application Centers of the Universities, the Turkish Language Proficiency Certificate issued by Yunus Emre Institute and the European Council Turkish Language Certificate.
- h. Registration procedures are carried out by the Student Affairs Department. Registrations of students with missing documents are not admitted.

EVALUATION OF APPLICATIONS, PLACEMENT PROCEDURES, CONTRIBUTION / TUITION FEE AND VISA / INSURANCE PROCEDURES

Evaluation of Applications

- a. The International Student Commission carries out the applications, preliminary examinations, examinations, selections and announcement of the results of the candidates who apply to the programs where our university accepts international students.
- b. As a result of the applications, the relevant unit carries out the evaluation procedures of the programs that admit students with the aptitude test.
- c. The scores of students with different international diploma score types are converted into a hundred (100) system and evaluated

Placement procedures

- a. The placement list of the candidates whose applications are admitted is announced on the website of our university on the dates specified in the academic calendar.
- b. Applications can be admitted again on the dates to be determined by our university for the quotas that remain vacant as a result of the placement process made on the dates specified in the academic calendar.
- c. While making the evaluation, if the diploma and success scores are equal according to the principles determined in Table-1, the younger candidate is preferred.
- d. The number of students from the same country admitted to a unit cannot exceed 20 percent of the total international student quota of the programs affiliated to this unit. If the quotas are not filled, candidates are placed in the unfilled quotas in order of success score, regardless of this rule.
- e. Hakkari University is free to fill the quotas or not. Meeting the application requirements does not require admission for placement.
- f. The acceptance letter of the candidates whose applications are admitted is sent to the email addresses they declared.
- g. Students who do not register on the registration dates lose their right to register.
- h. If the specified quotas are not filled, if deemed necessary, students can be admitted by the International Student Commission, taking into account the score and preference superiority, provided that the students apply in person.

Contribution / Tuition fee

The amount of contribution and tuition fees to be collected from international students who are entitled to study at our university are determined by the University Administrative Board within the framework of the decision of the President. The amount to be determined will be announced later on our website.

Study Visa

a) Candidates are required to get a "Student Visa" issued in their name and sent to the e-mail addresses specified in their applications, which will enable them to enter Türkiye for educational purposes.

b) International students who have completed their secondary education in Türkiye and want to study for a bachelor's degree without paying money, and children of foreigners who have a work and residence permit in Türkiye are not required to have a visa with a study permit.

General health insurance

Transactions with general health insurance for international students are carried out in accordance with the provisions of the relevant legislation.

Notification

All notifications to be made to students are made in writing to the e-mail address they provided during registration or by announcement in the unit to which the student applied. Students who report an incorrect or incomplete address or do not notify the change of address are deemed to have been notified if a notification is made to their existing address. If the student changes the contact information he/she declares, he/she is obliged to notify the Student Affairs Department within fifteen days.

Obligations of international students

International students who come to Türkiye to study or are in Türkiye are responsible according to the provisions of the relevant legislation in Türkiye.

Disciplinary affairs

The disciplinary affairs and procedures of the students are carried out in accordance with the provisions of the Higher Education Institutions Student Discipline Regulation.

LIST OF REGISTRATION DOCUMENTS

- 1. Original High School Diploma and its Turkish translation approved by a notary or Turkish Foreign Representatives,
- 2. Equivalence Certificate showing that the candidates' high school diplomas are equivalent to the diplomas received from Turkish high schools and obtained from the Republic of Türkiye Ministry of National Education (Education Attaché) or the Turkish Embassy (Education Consultancy) in their country,
- 3. The original of the document showing the graduation GPA and the certified copy from the Embassies or Consulates of the Republic of Türkiye translated into Turkish,
- 4. The original of the exam result document to be used in the application and the certified copy from the Embassies or Consulates of the Republic of Türkiye translated into Turkish, Foreign Language Proficiency Certificate,
- 5. if any, Foreign Language Proficiency Certificate,
- 6. if any, Turkish Proficiency Certificate,
- 7. A certified Turkish copy of the Student Visa obtained from Foreign Representatives or approved by the Turkish Embassy or Consulate,

- 8. A certified Turkish copy of the passport or ID obtained from official authorities or approved by the Turkish Embassy or Consulate,
- 9. Bank receipt showing that the tuition fee has been paid,
- 10. Photographs (5 pieces),
- 11. Official or notarized document or undertaking stating that the candidates have an income above the amount that will enable them to continue their education at the university (Foreign students who will continue their higher education at our university must provide documentation from the civil units in their country or their consulate in Türkiye that their financial situation is suitable for their education. The amount of financial security required for this is announced on the website of our university every year, together with other conditions.),
- 12. TR Identity Number statement or ID card photocopy of Turkish national candidates,
- 13. a document approved by the official authorities regarding the military service status of Turkish male candidates,
- 14. the original of the GCEAL exam result document for TRNC national candidates who completed their entire secondary education in TRNC high schools,
- 15. a copy of the residence permit (Applying to the Police authorities after registration and foreign national candidates who are obliged to obtain a residence permit must submit a copy of the residence permit).
